## **Participant Agreement, Release and Acknowledgement of Risk**

In consideration of the services of Calvary Family Martial Arts & Fitness Inc., also known as Calvary Family Hybrid Hapkido, Calvary Family Martial Arts & Fitness, Isaac Costley, their agents, owners, officers, volunteers, participants, employees, helpers, co-instructors, guest instructors, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as CFMAF), I hereby agree to release and discharged CFMAF (Isaac Costley, his family, and/or any persons representing Isaac Costley and/or CFMAF directly or indirectly) on behalf of myself, my children, my parents, my family, my heirs., assigns, personal representative and estate as follows:

1. I acknowledge that participation in martial arts and fitness entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, property or third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: intense, stressful and strenuous exercise and body contact. I expressly consent to voluntarily confront these known and unknown damages and further agree, understand and recognize that these risk may result in death, serious injury, or illness including but not limited to: muscle, tendon, and ligament pulls, tears, ruptures, strains etc., bloody noses, broken bones, dislocations, black eyes, heart attacks, or other cardiovascular disease, bruises, or other serious injury resulting in death and/or personal injury or property damage.

2. I expressly agree and promise to accept and assume all risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of all the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless CFMAF (Isaac Costley, his family, and/or any persons representing Isaac Costley and/or CFMAF directly or indirectly) from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of the equipment or facilities, including any such claims which allege acts of negligence or omissions of CFMAF (Isaac Costley, his family, and/or any persons representing Isaac Costley and/or CFMAF directly or indirectly).

4. I agree to hold CFMAF (Isaac Costley, his family, and/or any persons representing Isaac Costley and/or CFMAF directly or indirectly) in NO WAY RESPONSIBLE for any injuries sustained to myself or my family, no matter how slight or severe, to include the death of myself or my family member(s). I further prohibit anyone from suing CFMAF (Isaac Costley, his family, and/or any persons representing Isaac Costley and/or CFMAF directly or indirectly) on my behalf no matter the severity.

7. In summary, I waive all my rights to sue CFMAF (Isaac Costley, his family, and/or any persons representing Isaac Costley and/or CFMAF directly or indirectly) in any way. I assume all responsibility and am fully aware of all risks that come from participating in this activity to include severe and minor injuries, minor and major medical expenses, death, etc.
